Notice inviting Expression of Interest [EOI] for conducting certain *In Situ* Geotechnical Tests and Measurements at different sites in India.

CIMFR, Dhanbad, a constituent unit of Council of Scientific & Industrial Research, New Delhi, under Ministry of Science & Technology, Govt. of India, invites EoI for certain geotechnical investigations [as listed below] to be carried out in the different states of India on as-and-when-required basis.

Brief Scope of Work: To Conduct following *in situ* Geotechnical tests/measurements at sites in India as and when needed:

The selected agency will be responsible for (a) providing skilled manpower, machines and equipment for site preparation and testing or measurement, (b) their mobilization and maintenance, and (c) carrying out necessary geotechnical investigations at sites as decided by CIMFR in any part of India.

The quantum and type of geotechnical investigations at any site will depend upon the requirements of concerned mining and/or civil R&D projects of CIMFR, Dhanbad.

Period of contract: MOU will be initially for a period of 1 (one) year, which may be extended or curtailed by the C.A. on the basis of performance.

Interested established companies may submit their proposal in two sets on their letterheads in sealed envelopes narrating the following details.

1.	Name of the company, address & contact person, details of business being carried out.
2.	Financial details of the company along with the copy of Directors report, audited balance sheet and profit and loss account for preceding five financial years.
3.	Details of similar geotechnical investigations and analysis works carried out by the recent past showing types of investigation, values of works along with copies of work orders, completion certificates etc.
4.	Methodology to be adopted for carrying out each type of geotechnical investigation.
5.	Details of machines/equipments (field & ancillary equipment) owned by the company along with the documents providing their ownership.
6.	Details of existing manpower & personnel to be associated in case of award of work along with the bio-data of key persons.
7.	Any other relevant information.

The Proposal containing the details/credentials etc. should be submitted in a sealed envelope super-scribing "**Expression of Interest for conducting Geotechnical investigations**" and it has to be dropped in Tender box kept in the office room of Administrative Officer in CIMFR, Dhanbad. The last date of receipt of proposal is **18/09/2009** till 3 pm. It will be opened on the same day at 3.30 pm. The parties, who will submit EOI shall have to make a technical presentation and participate in pre-bid conference to be held on the next day **19/09/2009**. Based on the discussion, CIMFR will shortlist the eligible agencies to which the NIT with necessary details will be issued by CIMFR on the same day **19/09/2009**. Offers by Fax or e-mail will not be accepted. CIMFR will not hold any responsibility for any postal delay/misplacement of documents. Delayed or late submitted proposals shall be rejected straightway.

Director, CIMFR, Dhanbad, reserves the right to reject any or all proposals without assigning any reason whatsoever and not to proceed further in the work. The decision of Director, CIMFR will be final and conclusive.
